Under no circumstances shall the Company share UCI with any other entity, including a parent or subsidiary corporation, or any employee thereof.

6. I am an agent of the Company. There exists a principal agent relationship between me and the Company, which, for purposes of this form, means that the certifications contained herein are legally binding on both me and the Company.

7. For purposes of this form, I understand and agree that the term "foreign national" means an individual who is not a United States citizen.

10. I understand and acknowledge that DOE is providing the requested UCI for the specific purpose of responding to a Request for Proposals. Furthermore, I understand and acknowledge

that all Company employees approved to have access to the requested information will comply with Attachment 1 and the duties and responsibilities identified therein.

11. The Company will limit and control the reproduction and dissemination of the requested UCI to the minimum required for responding to the Request for Proposals.

12. I understand and acknowledge that the Company has a continuing obligation with respect to the requested UCI. In other words, the Company shall request DOE approval prior to providing any foreign national employee not identified herein with access to the requested UCI.

13. I understand and acknowledge that the Company may be contacted to verify the statements made herein and that DOE may visit the Company to ensure that proper information security practices are in place and are being followed. The Company agrees to cooperate fully in any DOE effort in this regard.

14. My statements in this form, and any attachments to it, are true, complete and correct to the best of my knowledge, information and belief. They are made in good faith for the purpose of obtaining access to certain Department of Energy UCI. I understand and acknowledge that a knowing and willful false statement in this form is punishable by fine or imprisonment or both, pursuant to 18 United States Code, Section 1001.
